He advised the Board that the Water Board had approved this application as a Commercial water tap. Steve explained that it is common for an applicant to request a water tap but not a water meter for various reasons. The applicant may want water to the property for resale reasons or the applicant may want water to the property but they do not intend to live there yet so will not be actually needing water at this time. He advised the Board that once the Water Meter is installed the Village starts charging for Water Service. Steve also advised the Board that all applicants will have to pay for any additional line required to connect their tap to the Village's water main line.
