Item #1 on the Agenda: Approval of the Agenda.

Dan Bolin made a motion to Approve the Agenda. J.R. seconded the motion. All were in favor.

Item #2 on the Agenda: Approval of the Minutes – September 22nd, 2020.

Dan Bolin made a motion to Approve the Minutes – September 22nd, 2020. Diane Riska seconded the motion. All were in favor.

<u>Item #3 on the Agenda: Discussion/Action – Application for Permit for New Construction at 116 Carole</u> Drive – Arthur Mendoza and Tina L. Martinez.

J.R. made a motion to Recommend Approval - Application for Permit for New Construction at 116 Carole Drive – Arthur Mendoza and Tina L. Martinez. Dan Bolin seconded the motion. All were in favor.
