The Purpose of this Public Hearing is to inform the Public that the Village of Capitan is going to raise the rate of the water and sewer bills for the Village of Capitan, beginning with April billing cycle. The Village has been working with the Rural Community Assistance Corporation in doing a rate study for the water and sewer. In doing this rate study, we have found that we are lacking in revenue, expenses, water consumption, inflation, system connections, reserve contributions, and financing of capital improvements, which if not realized, could increase the need to adjust rates. The Trustees were given five options. They have decided to go with The Village Trustee Option on sewer and Option #3 with the Addendum on the water.

The Propose Increases are: The base rate now for water is \$33.47 for 6000 gal. This would go up \$3.24 bringing the Base rate to \$36.61 for 3000 gal. The Base rate for Sewer is \$15.00 for 3000 gal. This would go up to \$17.00 + \$1.00 per 1000 gal.
